The Reporting Person disclaims beneficial ownership within the meaning of Section 16 of the Securities Exchange Act of 1934, as amended, or otherwise of such portion of the shares held by NEA 16 in which the Reporting Person has no pecuniary interest.
- On April 3, 2020, NEA 16 exercised a call option to purchase 1,500,000 shares of the Issuer's common stock ("Common Stock") for \$0.001 per share. NEA 16 paid the exercise price through the forfeiture of 564 shares of Common Stock.
- The call option became exercisable upon the closing of the Issuer's initial public offering.
